## **COMMISSION BUSINESS**

### **1. ORANGE COUNTY GREAT PARK WESTERN SECTOR ROADWAYS CAPITAL IMPROVEMENT PROJECT**

Scott Smith, Deputy Director of Public Works, and James Houlihan, City Engineer, presented the item and answered questions.

Commission discussion included: 1) the development of potential land use in the park; 2) identification of the cul-de-sac at the end of the extension of Bosque, between Hornet and Phantom, as a drop-off area; 3) traffic flow; 4) addressing possible traffic issues post-construction, should they arise, such as the use of signage to improve vehicle circulation; 5) concern was expressed and staff was encouraged to monitor vehicle circulation at the cul-de-sac/drop-off location, and prepare a list of alternatives to improve traffic flow, if necessary; 6) parking area impacts; 7) access to adjacent roadways; 8) timing required to accommodate the projected fall 2018 Great Park Ice Facility opening; and 9) a reminder that the project has already been approved and that the only an opportunity for the Commission to provide input is during the design phase; City Council-approved improvements will be included in the construction phase.

**ACTION: Moved by Commissioner O'Malley, seconded by Commissioner Casey, motion carried 3-0-2 (Commissioners Casey, Greenberg and O'Malley voted yes; Commissioners Montgomery and Moody were absent) to:**

Have staff consider circulation improvements, design alternatives, and other traffic mitigation elements for the extension of Bosque, between Hornet and Phantom.

## **ITEMS FOR FUTURE AGENDAS**

Vice-Chair Greenberg requested for staff to return to the Commission with alternatives addressing the continuing traffic issues at Jamboree, and for there to be a joint study session with City Council to discuss traffic flow improvements. Traffic at the intersection of Warner and Paseo Westpark raises the question as to what the process is for installation of new traffic signals; staff is asked to research and return to the Commission with information on the process.
