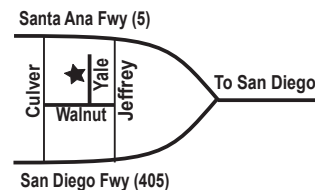

### JURYING PROCESS & AWARDS

The juror will select the artworks to be shown in the exhibition from the images submitted. Work which does not meet expectations set forth in the images may be withheld from the exhibition at the juror's discretion. The juror has the sole responsibility for the selection of the artworks. AWARDS are selected from the accepted entries. First Place - \$500, Second Place - \$300, Third Place - \$200

### ELIGIBILITY

Open to all artists residing in Southern California. All entries must be original and not shown previously at the Irvine Fine Arts Center.

**MEDIA:** All media is eligible: painting, photography, drawing, mixed media, sculpture, ceramics, crafts, installation, video and digital art.

**PRESENTATION:** Selected work must be ready to hang or exhibit; any special installation instructions must be provided in advance. Work over 60lbs must be handled by the artist during installation and removal. The artist is responsible for providing all special or unique display props. Work must remain on view for the duration of the exhibition.

### NOTIFICATION PROCESS

Notification of selected and non-selected work will be sent VIA E-MAIL (please include on entry form). If you do not have email, call 949-724-6894 to make other arrangements.

### EMAIL SUBMISSION

**Deadline for entries is Friday, June 12, 2015.** Once your entry form and payment have been received we will send you an email address where you will send your images. Please send them as (JPEG) attachments. The JPEG images should be sized at 8 x 10 inches vertical or horizontal at 96DPI. Please label the JPEG images as follows:

**FOR ENTRIES:** first name, last name, entry number: johnsmith1.jpg

**FOR DETAILS:** first name, last name, entry number, detail: johnsmith1a.jpg

### ENTRY FEES

\$20 for one entry. Additional entries \$12 each; maximum six entries.

Make checks payable to: "CITY OF IRVINE". **All fees are nonrefundable.**

## SELECTED ARTISTS: IMPORTANT

**DELIVERY OF ARTWORK:** The drop-off date for selected ARTWORK is Thursday, Friday and Saturday, July 30<sup>th</sup>, 31<sup>st</sup> and August 1<sup>st</sup> from 10am to 4pm ONLY unless other arrangements have been agreed upon in advance. Artists can bring an updated resume or biography, which will be made available to the public. Each shipped entry must be received by 5pm on Friday, July 31<sup>st</sup>, packaged in a reusable container for the return of work. There is no charge for hand delivered work. There is a handling charge of \$25 for shipped work. Shipping costs and insurance are the responsibility of the artist. Shipped artwork must be accompanied by a pre-paid return shipping label and a check payable to: "CITY OF IRVINE" in the amount of \$25 for the handling fee (paid separately from entry fee).

**PICK-UP OF ARTWORK:** Exhibited work will be available for pick-up on Monday, October 26<sup>th</sup> and Tuesday, October 27<sup>th</sup>, 2015 from 10am-8pm. Shipped work will be returned paid by the artist.

**COMPLETION OF LOAN AGREEMENTS:** A completed **LOAN AGREEMENT** must be submitted via email, mail, or dropped-off by the SELECTED APPLICANT or their agent prior to FRIDAY, JULY 24<sup>th</sup>. Artwork will not be eligible for exhibition unless the LOAN AGREEMENT is completed in its entirety prior to the deadline. FORMS will be emailed to all selected applicants; they can also be downloaded from the exhibition page on the Irvine Fine Arts Center website *IrvineFineArts.org*.

**LIABILITY:** Every reasonable precaution will be taken to ensure protection and careful handling of your artwork. The Irvine Fine Arts Center assumes no insurance liability for damage, theft or other loss occurring during delivery /pick up of artwork - insurance coverage applies only to the duration of the exhibition.

**SALES:** The Irvine Fine Arts Center will retain a 25% commission on any work sold during the exhibition; please consider this in your retail pricing. (Price is necessary for insurance value, even if not for sale.) Completed W-9 form will be required in the event of sale.

**AGREEMENT:** Submission of an entry form shall constitute agreement with all the conditions outlined in this prospectus. The Irvine Fine Arts Center reserves the right to photograph and reproduce art for use in promotional material.
