RED IMPORTED FIRE ANT QUARANTINE

The State of California has established a quarantine against the Red Imported Fire Ant (RIFA) in all of Orange County. As a result, restrictions have been placed on the movement of soil, including grading projects and swimming pool excavations. Such activities must be certified by RIFA Project Regulatory personnel. In cooperation with the State of California Department of Food and Agriculture, the City of Irvine will require RIFA certification prior to issuance of a grading or swimming pool permit, or any other permit involving the movement of soil.

Certification for movement of soil from or within the quarantined area may be made by contacting the RIFA Project and scheduling an inspection. Inspections are free and may consist of a visual survey or by trapping the area and determining if RIFA are present. If no RIFA are found at the site or origination, movement is permitted and a certification will be provided stating that the site was found negative for RIFA. If RIFA are found, movement will be prohibited until a pesticide treatment plan is established as required by Project personnel. Inspections may be scheduled (at least 3 days in advance) by returning the completed RIFA Form CA-1 (attached), via email or facsimile, to the Cooperative Red Imported Fire Ant Project. It will be the responsibility of the applicant to provide the City of Irvine with the completed RIFA Certification prior to issuance of the associated permit.
