2. ACCEPTANCE OF AGREEMENT FOR TRANSFER OR PURCHASE OF EQUIPMENT/SUPPLIES OR FOR REIMBURSEMENT OF TRAINING COSTS FOR FISCAL YEAR 2011 URBAN AREAS SECURITY INITIATIVE (UASI) GRANT

Kristin Beam, Public Safety Senior Management Analyst, presented the staff report and answered questions.

Commission discussion included: approval and expenditure process; breakdown of proposed expenditures; and transparency.

RECOMMENDED ACTION: Moved by Commissioner Chai, seconded by Commissioner Bollard, and unanimously carried by those members present to:

- 1) Recommend that the City Council authorize the Director of Public Safety to accept the Agreement for Transfer or Purchase of Equipment/Supplies or for Reimbursement of Training Costs for Fiscal Year 2011 Urban Areas Security Initiative (UASI) Grant.
- 2) Recommend that the City Council authorize the Director of Public Safety to accept equipment, technology, services or supplies purchased by the City of Santa Ana and transferred to the City of Irvine to enhance countywide emergency preparedness.
- Recommend that the City Council approve a budget adjustment request in the amount of \$270,000 in grant revenues and appropriations for training costs and necessary overtime for backfill; as well as equipment, supplies or services.
- 4) Recommend that the City Council authorize the Director of Public Safety to submit for reimbursement up to \$70,000 in training and

overtime costs, and \$200,000 in approved equipment, supplies or services through the Fiscal Year 2011 UASI Grant Program.

### 3. FISCAL YEAR 2011-12 DECEMBER BUDGET UPDATE

Lori Fisher, Senior Management Analyst, presented the staff report and answered questions. Donna Mullally, Fiscal Services Manager, was also present and answered questions.

Commission discussion included: variance explanation; documentary transfer tax; motor vehicle license fees; and revenue and expenditure trends.

RECOMMENDED ACTION: Moved by Commissioner Frank, seconded by Commissioner Chai, and unanimously carried by those members present to:

Receive and file the Fiscal Year 2011-12 December Budget Update.
