- Senior non-emergency medical transportation which reported to have 8,171 new client enrollment, 9,662 total trips during the same month and \$29.66 average cost per trip, at \$4.61 average cost per mile; and
- The Planning and Policy staff worked and participated in the Area Plan, in the Senior Services Employment program, and

various other series of events for the benefit and well-being of seniors.
