- Supervisor Blanco requested Boardmember contact information updates be submitted to staff.

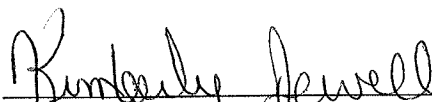

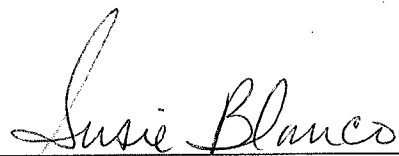

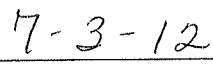
