# **BOARD BUSINESS**

# 1. DETERMINATION OF FY12-13 CHILD CARE PROVIDER RENTAL RATE

ICCP Administrator McClintic presented a request to approve the current rental rate plus a 3 percent increase for child care provider lease agreements for FY12-13. If approved, these lease increases would take effect July 1, 2012.

A discussion followed regarding: a) the pros and cons to increasing the lease agreement rental rates and the financial impact on families with child care needs of this action; b) the need for ICCP to have funds available for future new construction; and c) looking at alternatives to help provide financial support to ICCP other than increasing rent lease agreements. Administrator McClintic responded to the Board's questions and concerns.

Boardmember Lalloway suggested the ICCP work with developers in the future to explore options to help cover the cost of new facilities. John Fogarty, Chief Financial Officer (CFO) – IUSD, stated he would work with the ICCP Board to explore opportunities for financial support from development partners.

In addition, Boardmember Lalloway made the two following requests:

- 1. Asked that CFO John Fogarty provide a more detailed ICCP budget/financial projection for the next three years at the ICCP meeting on June 11; and
- 2. Requested that in the future, financial considerations such as this one be brought to the Board with a longer lead time.

**ACTION:** Moved by Boardmember Kuwabara, seconded by Clerk Battenfield by a vote of 3-2 to approve the current rental rate plus a 3% increase for the FY12-13.
