1. Distinguished Service Awards

Program Coordinator Amir Dorosti presented the Senior Citizens Council an informational PowerPoint presentation about the City's TRIPS program.

1. Transportation to Central County Senior and Caregiver Expo – Sheila Driscoll, Superintendent

Supervisor Kaleikini announced TRIPS will be available for transportation to the Central County Senior and Caregiver Expo on Saturday, August 25. Cost for round trip transportation will be \$7.

2. 2012 Global Village Festival - Sheila Driscoll, Superintendent

This announcement was postponed to the September meeting.

3. Rancho Senior Center Renovation Project – Ed Kaleikini, Supervisor

Supervisor Kaleikini announced Rancho Senior Center re-opened on August 13 following a two week closure for facility renovations. The renovation project included replacement of carpet, lighting fixtures and ceiling tiles, new tinted windows in the fitness center and administration office and a new fire alarm system. Additional upgrades will be completed in the next few months, including:

- a. Automatic restroom doors;
- b. Interior painting;
- c. Flooring in fitness center;
- d. Reupholstering of wall partitions; and
- e. Resurfacing front reception desk top and cabinets.

Councilmember Quader suggested the Senior Citizens Council meeting be held at Rancho Senior Center.
