2. REQUEST FOR A SIGN PROGRAM WITH ADMINISTRATIVE RELIEF TO THE ORANGE COUNTY PRINTING COMPANY BUILDING IN THE IRVINE BUSINESS COMPLEX (PLANNING AREA 36)

Zoning Administrator Connolly opened the public hearing.
