Boardmember St. Amant nominated by Boardmember Felix and seconded by Chair Jewell.


Nominations for Vice Chair:

Boardmember McLaughlin was nominated by Boardmember Gustin and seconded by Vice Chair Gibbons.


Motion to approve nominations unanimously carried by those members present.
