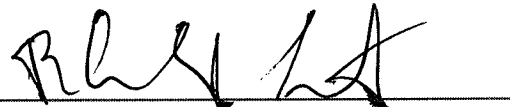
1. Minutes

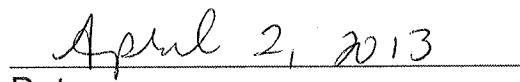
