**2. DESIGNATION OF REPRESENTATIVE TO HOUSING TASK FORCE**

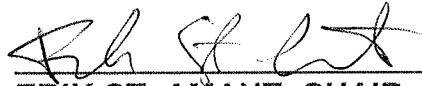
