B. Health and Nutrition

3. Senior Citizens Council Committees

A. Donor Committee

Supervisor Conger reported over \$18,000 in donations has been received in the first quarter of the calendar year. The Meals on Wheels program participated in the Mayors for Meals campaign with representation from Councilmember Shea by Council Executive Assistant Jessica Wu. Committee is working toward contacting service organizations to determine methods of disseminating Senior Services programs to their membership and to identify areas of possible fundraising partnerships. Next meeting is May 27 at 11 a.m. Supervisor Conger met with Hoag Memorial Hospital Presbyterian staff regarding senior health promotion programs and potential funding.

B. Facilities Committee

Councilmember Perdue reported Committee is working on future needs assessments. Future Committee meetings will focus on fact gathering and data collection in preparation of staff inquiries. Councilmember Perdue reported that he would like to work with Orange County Register to create a senior section in the paper.

C. Nutrition Committee

Supervisor Conger reported an external freezer will be purchased. The County program audit on April 15 went well and there were no preliminary findings, but need to wait for the official report which will be sent in August. Chair Wong commented that many compliments have been received regarding food quality and new lead cook.
