PRESENTATIONS

Committee Member Motta presented local hospital data pertaining to mental health admissions. He provided examples of cases being seen at the hospital, including admissions of teens and college students, and discussed the strain on the County's mental health care system to serve patients in a timely manner.

Manager Schneider-Jones informed the group of the City's efforts to determine child care need, as requested by the Planning Commission and Community Services Commission. The Irvine Child Care Committee has been involved in the process of developing a methodology for determining future needs created by new developments. Manager Schneider-Jones will update the group on progress of this project as it moves forward.

ANNOUNCEMENTS

Manager Schneider-Jones announced two upcoming community forums hosted by the Irvine Child Care Committee:

- How to Get Your Child Cooperating without Threats, Bribes and Consequences, to be held on Thursday, April 24, 2014 from 6-9 p.m. at City Hall, geared toward parents. A morning session for child care providers will also be held. The forums will be presented by Dr. Laura Markham, author of *Peaceful Parent, Happy Kids*. All participants will receive a copy of the book. The event costs \$15 for residents and \$20 for non-residents.
- *Play Counts! Workshop for Parents and Caregivers,* to be held on May 17, 2014 from 8:30 a.m.-3:30 p.m. at Rancho Senior Center. The event will be presented by Denita Dinger, co-author of *Let them Play: An Early Childhood Uncurriculum.*

The event is geared toward individuals who work with young children, but is open to parents. The cost is \$15 for residents and \$20 for non-residents.

Senior Management Analyst Laurie Gruschka provided an update on the City's Affordable Care Act forum held on January 29, 2014, with 38 attendees.

Superintendent Darin Loughrey provided an update on Middle School and High School Forums. A subcommittee of the Committee met on December 18, 2013 to discuss forum topic areas. Meeting attendees were: Committee Members Colocino and Gupta; Susan Holt from Irvine Unified School District; Bill Russell from Irvine Police; Manager Schneider-Jones; Superintendent Loughrey; High School Youth Action Team Program Coordinator Steve Knollmiller; Senior Management Analyst Gruschka. Ideas for forums included exploring career paths, stress management, and finding your passion. Based on the meeting, 13 school-based forums are scheduled for this school year. A citywide teen forum is also being planned on the topic of junior college as an educational path.

Senior Management Analyst Laurie Gruschka announced the City's annual food drive is taking place through March 31, 2014. She also announced that hard copies of the Strategic Plan for Children, Youth and Families Highlights report for 2011-12 are available to the Committee.

Member Colocino announced the next Irvine Prevention Coalition (IPC) meeting will be held on March 20, 2014. Mike Bergstrom of Irvine Police will present on Teens and Distracted Driving and the Smart Start program.
