1. VESTING TENTATIVE TRACT MAP 17497 TO SUBDIVIDE LOT 56 OF VESTING TENTATIVE TRACT MAP 17358 INTO 3 LOTS FOR FUTURE RESIDENTIAL DEVELOPMENT AND 1 LETTERED LOT FOR LANDSCAPE PURPOSES IN PLANNING AREA 20 (UNIVERSITY PARK)

Adopt Resolution No. 12-883 entitled - A RESOLUTION OF THE SUBDIVISION COMMITTEE OF THE CITY OF IRVINE RECOMMENDING PLANNING COMMISSION APPROVAL OF VESTING TENTATIVE TRACT MAP 17497 (FILE NO. 00551098-PTT) TO SUBDIVIDE 0.342-NET ACRES INTO 3 NUMBERED LOTS AND 1 LETTERED LOT FOR DEVELOPMENT OF 3 SINGLE FAMILY DETACHED RESIDENTIAL UNITS, AND LANDSCAPE PURPOSES ON LOT 56 OF VESTING TENTATIVE TRACT MAP 17358 GENERALLY LOCATED AT THE SOUTHWEST CORNER OF MICHELSON DRIVE AND ROSA DREW LANE IN PLANNING AREA 20 (UNIVERSITY PARK)

As amended, to add a "Whereas" section to the Planning Commission tentative tract map resolution tying back the residential map to the appropriate park plan resolution.
