2. VESTING TENTATIVE TRACT MAP 17485 IN STONEGATE (PLANNING AREA 9B)

Adopt Resolution NO. 12-884 – A RESOLUTION OF THE SUBDIVISION COMMITTEE OF THE CITY OF IRVINE RECOMMENDING PLANNING COMMISSION APPROVAL OF VESTING TENTATIVE TRACT MAP 17485 (FILE NO. 00548958-PTT) TO SUBDIVIDE A PORTION OF LOT 357 OF IRVINE'S SUBDIVISION SUBBLOCK 106 FILED IN BOOK 1 AT PAGE 88,INCLUSIVE; TOTALING 9.08 NET ACRES INTO 12 NUMBERED LOTS AND 9 LETTERED LOTS FOR THE DEVELOPMENT OF 96 ATTACHED RESIDENTIAL CONDOMINIUM DWELLING UNITS; INCLUDING A REQUEST FOR A DEVIATION FROM STANDARD PLAN 200A; LOCATED WITHIN PLANNING AREA 9B (STONEGATE); FILED BY IRVINE COMMUNITY DEVELOPMENT COMPANY

3. VESTING TENTATIVE TRACT MAP 17486 TO SUBDIVIDE 5.99-ACRES INTO 227 LOTS FOR FUTURE RESIDENTIAL DEVELOPMENT AND 9 LETTERED

LOTS FOR LANDSCAPE AND PRIVATE DRIVE PURPOSES IN STONEGATE (PLANNING AREA 9B)

Stephen Higa, Principal Planner, presented the staff report on behalf of Bill Rodrigues, Senior Planner.

Adopt Resolution NO. 12-885 – A RESOLUTION OF THE SUBDIVISION COMMITTEE OF THE CITY OF IRVINE RECOMMENDING PLANNING COMMISSION APPROVAL OF VESTING TENTATIVE TRACT MAP 17486 (FILE NO. 00548173-PTT) TO SUBDIVIDE 5.99-ACRES INTO 27 NUMBERED LOTS FOR FUTURE LANDSCAPE AND A PRIVATE DRIVE; GENERALLY LOCATED BETWEEN PORTOLA PARKWAY, ENDICOTT, BERKSHIRE, AND FENWAY IN PLANNING AREA 9B (STONEGATE); FILED BY THE IRVINE COMMUNITY DEVELOPMENT COMPANY
