Adopt Resolution No. 12-886 – A RESOLUTION OF THE SUBDIVISION COMMITTEE OF THE CITY OF IRVINE RECOMMENDING PLANNING COMMISSION APPROVAL OF VESTING TENTATIVE TRACT MAP 17415 (00549069-PTT) TO SUBDIVIDE A PORTION OF LOT 1 OF TRACT 17420 IN THE CITY OF IRVINE, COUNTY OF ORANGE, AS FILED IN BOOK 907, PAGES 43-50, INCLUSIVE OF MISCELLANEOUS MAPS, IN THE OFFICE OF THE COUNTY RECORDER, TOTALING 49.98-ACRES INTO 228 NUMBERED LOTS AND 114 LETTERED LOTS FOR THE DEVELOPMENT OF UP TO 329 RESIDENTIAL DWELLING UNITS AND A PRIVATE NEIGHBORHOOD PARK LOCATED IN PLANNING AREA 40; FILED BY THE IRVINE COMMUNITY DEVELOPMENT COMPANY

5. VESTING TENTATIVE TRACT MAP 17490 IN STONEGATE (PLANNING AREA 9B)

Chair Jacobs opened the public meeting at 9:08 a.m.

Justin Equina, Assistant Planner, presented the staff report.

Jeffrey Tang, representing Urban Resource, was present and available to answer questions.

Jamie Yoshida, representing Irvine Community Development Company, was present and available to answer questions.

Andy Best, representing Community Services, had questions regarding parking on the street across from the park. Discussion ensued regarding parking on Ovation Street, parking allotment and related issues. Mark Carroll, representing Engineering, noted that Standard Condition 2.12 and 3.1 were both missing from the Resolution No. 12-888.

Joseph Kirkpatrick, representing Planning & Development Services, agreed that both Standard Conditions should be added to Resolution No. 12-888.

Chair Jacobs requested public comments.

Jamie Yoshida, representing Irvine Community Development Company, agreed to the inclusion of both Standard Conditions to Resolution No. 12-888.

Chair Jacobs closed the public meeting at 9:11 a.m.

Adopt Resolution No. 12-888 – A RESOLUTION OF THE SUBDIVISION COMMITTEE OF THE CITY OF IRVINE RECOMMENDING PLANNING COMMISSION APPROVAL OF VESTING TENTATIVE TRACT MAP 17490 (FILE NO. 00548931-PTT) TO SUBDIVIDE A PORTION OF BLOCK 106 OF IRVINE'S SUBDIVISION AS SHOWN ON A MAP RECORDED IN BOOK 1, PAGE 88 OF MISCELLANEOUS RECORD MAPS, TOGETHER WITH A PORTION OF PARCEL 1 OF LOT LINE ADJUSTMENT 411294-LL/LL 2006-012; TOTALING 1932 NET ACRES INTO 128 NUMBERED LOTS AND 19 LETTERED LOTS FOR THE DEVELOPMENT OF 127 SINGLE-FAMILY DWELLING UNITS AND 1 PRIVATE PARK; LOCATED WITHIN PLANNING AREA 9B (STONEGATE); FILED BY URBAN RESOURCE CORP., ON BEHALF OF IRVINE COMMUNITY DEVELOPMENT COMPANY
