A regular meeting of the Zoning Administrator was called to order at 1:30 p.m., on February 26, 2014, at the Irvine City Hall in Conference Room L102, One Civic Center Plaza, Irvine, California; Zoning Administrator Paul Connolly, presiding.

2. REQUEST FOR CONDITIONAL USE PERMIT FOR A NEW CLASS 1 WIRELESS TELECOMMUNICATION FACILITY AT THE MARKET PLACE CENTER IN LOWER PETERS CANYON

Zoning Administrator Connolly opened the public hearing.

Marie Luna, Senior Planner, presented the staff report. An Errata was presented that Condition 6.19 of ZA Resolution 14-1224 refers to Exhibit A

being included with the Resolution. Exhibit A was inadvertently omitted and was presented to the Zoning Administrator Connolly.

Also noted on the Errata was Exhibit A on Page 3 of the previously approved sign program for Jamboree Center was approved by ZA Resolution 10-1013 on March 10, 2010 (#00496919-PSS). The Sign Program includes a legend which illustrates an area within Jamboree Center where ground signs are not subject to this Sign Program or the Zoning Ordinance.

David Baab and Associates on behalf of Irvine Company Retail Properties was present and available to speak on the project if needed.
