3. VESTING TENTATIVE TRACT MAP 17814 TO SUBDIVIDE 7.04-ACRES INTO NUMBERED LOTS FOR FUTURE RESIDENTIAL DEVELOPMENT AND A PRIVATE PARK AND LETTERED LOTS FOR LANDSCAPE AND PRIVATE DRIVE PURPOSES IN CYPRESS VILLAGE (PLANNING AREA 40)

Kathleen Haton, Contract Planner, presented the staff report and noted a correction to the description within the report indicating that Waterleaf is a private street. Waterleaf is a public street and located outside the map boundaries.

Afshin Shahidi of Hunsaker & Associates and Jamie Yoshida of the Irvine Community Development Company were present in support of the project and available to answer questions.

Members Carroll and Reynolds asked if special requirements may be necessary in order to provide waste collection services due to space restrictions. Jamie Yoshida responded that there are no radius deviations from prior approval of the Master Plan.
