# 2. VESTING TENTATIVE TRACT MAP 17607 IN PORTOLA SPRINGS (PLANNING AREA 6)

Chair Jacobs opened the public meeting.

Joel Belding, Senior Planner, presented the staff report.

Chair Jacobs requested public comments.

Jon Omora resident of Portola Springs expressed concerns about increased noise and submitted a proposal which has been signed by residents of the Las Ventanas tract requesting that the developer provide a sound wall.

Elizabeth, an Irvine resident, spoke in opposition to the proposed residential dwellings and expressed concerns about overcrowding in area schools.

Robert McMurry, speaking as an abutting property owner, stated that he requested, but was not provided with, a copy of the Tract Map for Planning Area 6 prior to this meeting. He expressed concerns about Environmental Clearance for the proposed project.

Jeff Davis, representing the Irvine Community Development Company, spoke in support of the project and provided background information addressing the issues raised by members of the public concerning compliance for this Planning Area.

Irvine resident Jon Omora reiterated his position that a sound wall is needed to address the increased traffic flow that is to be expected on Portola Parkway.

Chair Jacobs addressed members of the public and clarified the role of the Subdivision Commission to provide review of technical issues. Planning Commission will consider larger policy level issues at their future meeting and if more discussion is needed residents may also attend the City Council as these items of concerns are addressed.

Chair Jacobs closed the public meeting.

ACTION: It was moved by Chair Jacobs, seconded by Member Carroll and approved by the following vote to adopt Subdivision Committee Resolution 13-907 with revisions to Condition 1.1 and correction to finding "I" to reference Planning Area 6 rather than Planning Area 5B.
