Ken Brown, Director of Administrative Services, introduced and provided background on Don Collins, new City Treasurer, to the Finance Commission.

COMMISSION BUSINESS

1. COMMISSION DISCUSSION: INFRASTRUCTURE & REHABILITATION FUNDING

Discussion focused on the following subjects: identifying current and prospective infrastructure and rehabilitation funding needs; delineation of facilities included and not included in this year's study of rehabilitation needs for facilities 30-years and older; developing a systematic facility rehabilitation funding strategy focusing on concepts such as "rent" or "depreciation"; and defining the use of different infrastructure funding sources within the budget document.

The Finance Commission agendized a discussion on cost recovery for non-resident participation in City programs and facility rental rates at the next meeting.

2. MINUTES

3. TREASURER'S REPORT FOR THE QUARTER ENDED DECEMBER 31, 2014

Don Collins, City Treasurer, presented the staff report and answered questions. Ken Brown, Director of Administrative Services, was present and also answered questions.

Commission discussion included: average weighted yield of Bond Proceeds Fund Portfolio and the Special District Funds Portfolio; liquidity needs; unrealized losses and gains; prepaying vendors for better return on investment; vehicle leasing debt; interest rates and market risk; fees and costs of the City's Investment Manager.

ACTION: Moved by Vice Chair Stein, seconded by Commissioner Dressler, and unanimously carried to:

Recommend that the City Council receive and file the Treasurer's Report for the quarter ended December 31, 2014.

4. FISCAL YEAR 2014-15 DECEMBER BUDGET REPORT

Peter Hong, Management Analyst II, presented the staff report and answered questions. Ken Brown, Director of Administrative Services, Donna Mullally, Manager of Business & Budget Planning, and Teri Washle, Interim Manager of Fiscal Services, were also present and answered questions.

Commission discussion included: anticipated sales tax growth and property tax revenue; time required to fill staff vacancies; interest earnings within the Infrastructure and Rehabilitation fund in relation to CIP projects; status of funds received from OCFA; upcoming negotiations; and the Orange County Public Library set-aside account fund revenues.

ACTION: Moved by Commissioner Dressler, seconded by Commissioner Wong, and unanimously carried to:

Receive and file the Fiscal Year 2014-15 December Budget Update.
