Facilitator Loughrey circulated a spreadsheet surveying adaptability of locating an alternate disc golf course at an Irvine park or other public facility. Task Force members were requested to provide feedback on alternate course locations at the next meeting.

Task Force members participated in a brainstorming session regarding Deerfield safety modifications. Facilitator Loughrey indicated he would bring the brainstorm list back to the group at the May 21, 2015 meeting to evaluate and prioritize recommended safety measures.

Task Force members discussed inclusion of a community survey as part of their work to determine if safety measures will achieve desired results.

PUBLIC COMMENTS

Doug Jacobs, a disc golf advocate, spoke about possible park modifications that may increase course safety.

Wendy MacNey, a Deerfield Village resident, spoke about the negative impacts disc golf has on her property and the park.
