#### 2. IRVINE CHILD CARE PROJECT PROPOSED BUDGET FOR FY 2015-16 WITH MULTI-YEAR BUDGET PROJECTION

Discussion included: Annual rent increase of 3 percent is included due to anticipated cost escalations; increases in custodial costs for FY 2016-17 are due to the opening of Portola Springs and Beacon Park (previously referred to as Heritage Fields) schools; costs for portable buildings at Portola Springs in FY 2015-16 and for Eastwood Village in FY 2016-17; projected increase in program coordination costs in FY 2016-17 for the addition of City staff for administrative support due to opening of new sites.
