**1. BOARD/COMMITTEE BUSINESS**

**1.1 FOCUS GROUP DISCUSSION TO PROVIDE INPUT IN THE AREAS OF AQUATICS AND ATHLETICS TO BE USED TO DEVELOP A CITYWIDE PARKS AND FACILITIES MASTER PLAN**

Principal Planner Nicandro introduced Esmeralda Garcia and Jose Rodriguez of MIG, the consulting firm hired to develop a Parks and Facilities Master Plan, who led the focus group workshop.

Board/Committee discussion included needs for: adequate/additional parking at venues hosting large events; consideration of underground parking structures with synthetic turf on surface facilities dedicated to disabled youth; dedicated athletic fields with lighting for evening programming; a second aquatics facility; additional batting cages; additional public restrooms across park/open space system; bullpens on ball fields; drainage on fields with flooding/pooling issues; consideration for facilities to accommodate growing demand for new sports such as rugby, cricket and lacrosse; gymnasiums to provide opportunities to youth not interested in traditional, organized, team sports; evaluation of underutilized facilities to repurpose/reprogram; designated practice/training facilities versus game/competition facilities;

additional synthetic turf facilities; continuance of trail connectivity to parks/fields; and increased exposure to promote participation in girls/women's sports.


