David Baab, Baab & Associates, reviewed the proposal and displayed sample signage; requested approval for the oversized Valet Directional Sign.

Zoning Administrator Connolly closed the public hearing; opined that the smaller Valet Directional Sign proposed by staff is adequate for its purpose.
