2014-15 Irvine Child Care Salary and Tuition Survey

Community Services Program Coordinator Diana Castaneda presented the results of the Irvine Child Care Salary and Tuition Survey that was compiled by the City of Irvine Child Care Coordination Office for informational purposes. The survey examined the average cost of center-based child care for infant/toddler, preschool and school age children in Irvine. Additionally, the survey provided information on the average wages and benefits received by early care and education providers in Irvine. A summary of the results were distributed to Committee members.

Supervisor Stubbler announced the recruitment for two child care provider and two government, civic, or community agency members is now open. Applications are available online and at the Child Resource Center. Applications must be submitted by September 30.

5. New Child Care Programs

Program Coordinator Castaneda announced the new Spectrum Montessori has opened their second location in Irvine as of September 1, serving 48 infants and toddlers and an additional 144 preschool age children. Rainbow Rising has opened at its permanent location on the new Portola Springs Elementary school campus. The program is at capacity with 115 school age children.
