Cameron Hum, representing Lifetime Memories, gave input about three of his concerns; (1) increase in complaints from new residences, (2) increase in grid-lock traffic between 4:30-6 p.m. at Cartwright and Main Street and (3) increased water usage.

Member Carroll responded to Cameron Hum's comments regarding increase in grid-lock traffic and obtained his contact information for traffic study input.

Chair Jacobs responded to Cameron Hum's comments regarding water usage.

Tim Strader, representing Starpointe Ventures, requested removal of Condition 1.15 ACCESS EASEMENT WITH 2505 DA VINCI and provided handouts of proposed alternative.

Member Carroll responded to Tim Strader's request and recommendation was given to keep Condition 1.15.
