C. Nutrition Committee

Councilmember Woollett reported on updates provided by Nutrition Program Coordinator Damion Coran regarding replacement of kitchen equipment and menu revisions being considered to meet new federal nutrition guidelines. Daily attendance for meal service continues to increase and staff is exploring options to meet demand. Staff is also reviewing options to meet demands for the Irvine Meals on Wheels program, including shelf stable meals that will not require refrigeration. The Community Action Partnership food commodities program provides 270 income-eligible Irvine seniors with a 30-lb food box each month.
