1. ABLE Act verses Special Needs Trust

Boardmember Harvey provided an update on the ABLE Act. Ohio is the first state to implement the Able Act. It has been a challenge to utilize Housing and Urban Development (HUD) in Irvine, parents are unable to supplement finances, and first and third party trusts are different.
