- Board member Robert shared concerns about the low numbers of para-athletes interested in the Irvine Unified School District (IUSD) para-athletics program and potentially the Irvine Junior Games. Para-athletes invited to participate in para-athletic programs are the fourth through eighth grades students. Students must be in grades 4 through 8 and enrolled in the IUSD. This item has been agendaized for the next regular meeting on January 3, 2017.
- Boardmember Stern announced she attended Senior Services Strategic Plan meeting on September 29, 2016 and complimented the process and outcomes of the meeting. Leading challenges with seniors are mental and physical health, language barriers between caregivers and participant.

- Boardmember Jewell commented how great the Technology Innovation for Public Safety (TIPS) program is in Irvine. She recently experienced the service and was very pleased. She was unaware of this program being available to Irvine residents in the past.
