INTRODUCTIONS

Community Services Manager Corinne Schneider-Jones introduced new Senior Councilmember Rachel Owens.

1. Distinguished Service Awards

Social Services Supervisor Lynne Conger presented this award to the Flying Geese Quilters Guild for their beautiful quilted placemats provided for Meals on Wheels participants. The club began in 1985 with only 35 members, and has grown to over 250 members who enjoy quilting and providing service to the community through their craft.

Community Services Supervisor Ed Kaleikini presented this award to the Billiards Committee for their dedication to ensuring the billiard room and equipment is well maintained, players enjoy their time and for organizing games and tournaments.

Supervisor Kaleikini announced this project will be presented to City Council in March.

PUBLIC COMMENTS

Don Perdue, Irvine resident, commented on his perception of Irvine as a multi-ethnic diverse community and that there are many cultural cliques at Lakeview Senior Center. He suggested the City create a Cultural Commission to support assimilation of cultural groups and that the City take a more active role to support interaction between cultural groups, including a stronger approach to English Mentoring. Don Purdue also spoke about Art in Public Spaces.

IADHS also used Facebook as a resource to post a request seeking donations toward the purchase of a restaurant grade food processor, and within the day, had received enough funds to make the purchase. IADHS will host a fundraiser on March 28 at MOD Pizza. Friends of Outreach donated \$1,250 toward the IADHS Scholarship Assistance Fund that awards an estimated \$15,000-20,000 annually.
