EXECUTIVE SUMMARY

Organization of the Green Ribbon Environmental Committee (Committee) including the selection of a Chairperson, Vice Chairperson and Committee meeting dates, is required. Environmental Programs Administrator Coffee will declare nominations open for the Chairperson position and will call for the Committee to vote. Then the newly-elected Green Ribbon Environmental Committee Chairperson will declare nominations open for Vice Chairperson, and call for the Committee vote.

The Committee Calendar also needs to be set. Per January 8, 2013 City Council action, the Committee meets four times per year. The day, time and place is to be determined by the Committee. The newly-elected Committee Chairperson will open discussion regarding day, time and place for meetings.

ANALYSIS

According to the Committee bylaws, the Committee shall have the constituted offices of Chairperson and Vice Chairperson. The Committee will elect officers at its first meeting, and annually at the first meeting of each calendar year thereafter.

Chairperson and Vice Chairperson Responsibilities

The duties of Chairperson include maintaining the general supervision, direction and control of the Committee meetings. The Chairperson shall preside at all meetings of the Committee, receive requests for agenda items from Committee members, represent and speak on the behalf of the Committee at City Council meetings, and shall have the power to appoint subcommittees of the Committee and subcommittee Chairpersons as necessary and receive reports of the subcommittee's activities.

The duties of Vice Chairperson include acting in the absence of the Chairperson, performing all the duties of the Chairperson, and in so acting, have all the powers of the Chairperson.

Selection of Committee Calendar

Per January 8, 2013 City Council action, the Committee meets four times per year. The day, time and place is to be determined by the Committee.

At this time, staff is able to make room reservations for Committee meetings for the remainder of the 2017 calendar year. The third Tuesday of the month at 4:30 p.m. has been identified as a time that does not conflict with City Council meetings, and was available to Committee members.

Following the quarterly meeting schedule, the next Committee meeting is tentatively scheduled for August 15, 2017 in Room L102 at the Civic Center. Staff has also reserved Tuesday, November 21, 2017 at the Conference and Training Center for the last Committee meeting of 2017.

If the Committee chooses to follow this quarterly meeting schedule, the meetings in 2018 would take place on the third Tuesdays of the month: February 19, May 15, August 20, and November 19. The facility locations are not yet available, but staff can continue to book rooms located in the Civic Center or can search for availability of other City facilities.

All meeting dates and locations will be posted on the City's website to notify the public of upcoming meetings.

Appointed January 10, 2017

leadership that transcends political affiliation is the hallmark of her service. She is a prolific and effective bridge builder that is highly skilled in identifying and matching organizations or individuals that can make a bigger and more positive impact together than they could ever do apart.

Member-At-Large appointed April 25, 2017



RECOMMENDED ACTION

Adopt Green Ribbon Environmental Committee Work Plan.

EXECUTIVE SUMMARY

One of the duties of the Green Ribbon Environmental Committee (Committee) is to prepare a Work Plan outlining the focus of the Committee. According to the bylaws, this task shall occur at the first Committee meeting. To assist with this task, staff has prepared a Work Plan for the Committee's consideration that focuses on the work the Committee can contribute to over the next two years. Once approved by the Committee, the Work Plan will be provided to the City Council for its consideration.

ANALYSIS

The Committee Work Plan is intended to prioritize focus areas and goals for the Committee and to guide its work over the next two years. To provide some context for the Committee's adoption of a Work Plan, the Committee can consider the following mission statement consistent with the bylaws:

The mission of the Green Ribbon Environmental Committee is to advise the City Council on sustainability policies related to energy, recycling and waste management, mobility, open space and water issues. The Committee's values shall reflect the interests and needs of the community. Recommendations made to City Council will focus on improving the livability of the community, while supporting Irvine's growing and diversified economy.

The draft Work Plan outlined below covers issues of priority to the City of Irvine. The Committee may choose to annually review the Work Plan to assess progress and make new additions to the Work Plan as needed. Once adopted, the Work Plan will be provided to the City Council for its consideration and approval.

Committee Work Plan

The draft Work Plan outlines broad policy areas that fall under the Committee's purview. These areas include energy, which is an area of current focus for the City, grants in environmental areas, business-friendly initiatives and economic development. Pursuant to this work plan, the Committee will consider policies that support each of these areas.

Energy Plan Update:

An Energy Plan for the City has not been updated since 2008. Much has changed since then regarding technology, including energy production. Staff will be working on updating the City's Energy Plan over the course of the next 18 months. The City's Energy Plan will be subject to the City Council's approval. Staff will seek input from the Committee on policy related matters contained in the draft updated plan.

Grants and Pilot Programs:

When looking at grant opportunities across all environmental areas – energy, waste management, water, open space – staff aims to seek out grants that serve policy objectives of the City. Staff will work with the Committee to identify policy objectives that will help set priorities for grant applications and any pilot programs to be proposed to the City Council for its consideration.

Economic Development and Business Friendly Initiatives:

Staff will work with the Committee to develop draft policies that are business-friendly and promote sustainable economic development opportunities for the City.

ALTERNATIVES CONSIDERED

The Committee may consider modifications to the policy areas listed in the Work Plan.

The next Committee meeting is tentatively scheduled for August 15, 2017.

FINANCIAL IMPACT

There are no costs associated with adopting the Committee Work Plan.
