2. WEEKDAY COMMUTER ISHUTTLE ROUTE EXPANSION AGREEMENTS

Mike Davis, Transit Programs Administrator, Transportation department presented the item and answered questions. Jaimee Bourgeois, City Traffic Engineer, Transportation department was also available for questions.

Commission discussion included: City ridership measurement, procedures to establish new routes, congestion mitigation, high-demand area selection process, distance between stops, potential additional stops for Lakeview Senior Center and the Irvine Train Station, purchase and installation of signage, fare funding allocation, the need for additional marketing for John Wayne Airport service, potential for bike share, UCI service, and commuters surveying on means of transportation to the train station.

John Boslet responded to questions about the funding support letter from the Irvine Company.

ACTION: Moved by Commissioner Moody, seconded by Commissioner Casey, motion carried 4-0-1 (Commissioners Montgomery, Greenberg, Casey and Moody voting yes; Commissioner O'Malley absent) to:

Recommend that the City Council approve the proposed new Spectrum and IBC weekday commuter iShuttle routes for funding by the Measure M Project V grant program and the agreements.

ACTION: Moved by Commissioner Greenberg, seconded by Commissioner Moody, motion carried 4-0-1 (Commissioners Montgomery, Greenberg, Casey and Moody voting yes; Commissioner O'Malley absent) to:

Recommend additional study and future discussions for: the Lakeview Senior Center as a possible stop, bicycle sharing from the Irvine Train Station to the IBC area, work with the School District to expand carpooling, review the marketing program to expand the promotion of the iShuttle.
