## B. Irvine Evergreen Chinese Senior Association (IECSA)

Director Jerry Chang announced the Chinese New Year event will be held today starting at 10 a.m. A list of entertainers and menu was shared. The Senior Council was invited to join in the celebration following the Senior Council meeting.

Representative Natalie Chaikin reported on the annual travel show held on Friday, February 9 at the Lakeview Senior Center. The event was well attended and included refreshments and opportunity drawings. A decline in travel bookings for one-day and extended tours was reported at the travel show, possibly due to economic concerns or competition with nearby groups. Fliers for upcoming excursions and tours are available at the senior centers.

### E. NEDA-Association of Iranian American Seniors (NEDA)

Treasurer Nasser Fathi reported the Persian New Year will be on March 21, and NEDA will host a celebration on March 15 from 6 to 9 p.m. Program includes live music and traditional Persian food will be served. A new music program, Daf Drumming, has been added to the daily program with an average participation of 30 members. All are invited to attend and participate in NEDA programs.

# 2. Orange County Senior Citizens Advisory Council-Affiliated Committees

# A. Orange County Senior Citizens Advisory Council

Chair Inmon reported a presentation on the Orange County Strategic Plan on Aging was provided and measurable outcomes were reported on Nutrition. One of the programs highlighted was senior grocery distribution, which includes grocery recovery and a mobile food distribution trailer concept to be launched called the "Park-It Market". It was also reported that distribution of redesigned Medicare cards is expected to begin in April and will take approximately two and half years for Medicare recipients to receive their new cards.

Social Services Supervisor Lynne Conger shared that she and other City staff participate in several of the sub-committees for the Orange County Strategic Plan on Aging and interested members are welcome to attend.

#### B. Health and Nutrition

Senior Council Member Jones reported the Health and Nutrition Committee will meet next week.

## C. Housing and Transportation

Senior Council Member Kim reported a presentation on the City of Placentia's Veteran's Village was made by City of Placentia Director of Development Services Joseph Lambert. This \$21 million dollar development will bring permanent supportive housing (50 furnished apartment homes) to the estimated 3,500 military veterans in Orange County who are homeless or disabled.

### D. Legislative

Vice Chair Ranjbar reported the February 5 meeting included a discussion about legislation regarding prescription labeling. John Pointer, Chair of the Orange County Senior Citizens Advisory Council, spoke about the California Association of Area Agencies on Aging (C4A) Caucus.

The topic of funding for nutrition services was also discussed by the Legislative Committee and seems to be a top priority.

#### 3. Senior Citizens Council Committees

#### A. Facilities Committee

Senior Council Member Kondru reported routine items were discussed. Supervisor Kaleikini shared the automatic restroom doors at Trabuco Center have been installed and are fully operational.

# B. Leadership Committee

Senior Council Member Jones reported the Committee will continue to meet quarterly, but the meeting months have been changed to February, May, August, and November. The process on how information related to emergency procedures is shared with senior program participants and rental groups was discussed. Fitness Center memberships have increased and new fitness center staff was introduced. IKEA is working to promote programming that supports the integration of high school students and seniors. NEDA is starting a technology program linking teens and seniors.
