1. APPROVAL OF COMMITTEE MINUTES

ACTION: It was moved by Chair Jacobs, seconded by Member Kirkpatrick to adopt the Minutes of Regular Meeting of the Subdivision Committee held on November 22, 2017. Member Murillo supported the motion and members Nicandro and Pham were not present at this meeting and abstained.

2. AMENDED VESTING TENTATIVE TRACT MAP NO. 17939 GENERALLY LOCATED WEST OF RIDGE VALLEY BETWEEN IRVINE BOULEVARD AND GREAT PARK BOULEVARD IN PLANNING AREA 51 (GREAT PARK NEIGHBORHOODS, DEVELOPMENT DISTRICT 1-WEST)

Chair Jacobs opened the public meeting at 9:01 a.m.

Sherman Jones, Senior Planner, presented the staff report and an errata sheet. Bill Rodriques, Principal Planner, was also available to answer questions.

Discussion included 1) clarification of parks and how much is provided, 3.49 acres (or its equivalent) is the minimum requirement and should be spelled out in the "park plan approval" condition; 2) Member Kirkpatrick noted that standard conditions 2.21 (Park Playground) and 3.3 (Disclosure statements) needed to be updated due to recent changes and requested the addition of Standard Condition 4.12 (Phased occupancy of multi-building residential development)

Patrick Strader, Starpointe Ventures obo Heritage Fields El Toro, LLC was available to answer questions and noted that they were in agreement with the errata sheet.

Chair Jacobs closed the public meeting at 9:20 a.m.

Adopt Resolution No. 17-1021 – A RESOLUTION OF THE SUBDIVISION COMMITTEE OF THE CITY OF IRVINE, CALIFORNIA RECOMMENDING PLANNING COMMISSION APPROVAL OF AMENDED VESTING TENTATIVE TRACT MAP NO. 17939 (FILE NO. 00727257-PTT) TO SUBDIVIDE APPROXIMATELY 55.3 GROSS ACRES INTO 53 NUMBERED LOTS FOR 723 RESIDENTIAL CONDOMINIUM UNITS, WATER QUALITY, PRIVATE NEIGHBORHOOD PARK PURPOSES; AND 46 LETTERED LOTS FOR CIRCULATION AND LANDSCAPE PURPOSES, LOCATED IN DEVELOPMENT DISTRICT 1-WEST OF GREAT PARK NEIGHBORHOODS IN PLANNING AREA 51; FILED BY HERITAGE FIELDS EL TORO, LLC
