1. Senior Services Support/Interest Groups

A. Irvine Adult Day Health Services (IADHS)

Executive Director Kimberly Beeson reported Atria has partnered with IADHS for a "wine grab" fundraiser on July 19 and will also be a dessert sponsor for the annual casino night fundraiser on October 6. IADHS was awarded a \$500 Community Partnership Grant at a recent City Council meeting. Installation of an upgraded wander guard system is scheduled for May 21 with no interruption to programs/services. IADHS average daily participation is between 44 and 57, with a month-to-date average of 51 (capacity is 60). Some program changes include breaking larger group activities into smaller groups allowing for more varied activities, spread throughout the day and the center.

B. Irvine Evergreen Chinese Senior Association (IECSA)

Director Jerry Chang reported elections will be held on May 19 to fill six Director seats for 2-year terms. The date will also include a Mother's Day celebration featuring cultural dance and music. A day trip to Lake Arrowhead is scheduled for June 2.

C. Friends of Outreach (FOO)

President Pat Hendee reported Bingo program participation decreased the past month. The International Crafters continue their work on holiday gift bag items, and have made 120 scarves and 64 placemats to date. An opportunity drawing will be held at the July holiday luncheon. The Chili's restaurant fundraiser event earned \$85, there will be another event on June 14 at Rodrigo's restaurant in

Tustin, and at the California Pizza Kitchen on Alton and Jeffrey in September. In 2017, Uber donated \$1,035 to FOO, and 2018 year-todate donations total \$588. FOO has provided \$250 in donations toward a special needs clean-up project.

2. Orange County Senior Citizens Advisory Council-Affiliated Committees

A. Orange County Senior Citizens Advisory Council

Chair Inmon reported the May 11 meeting included a presentation on Elder Abuse awareness and Nutrition updates. A pilot program will begin in June featuring the "Park It Market", where food trucks will be used as a traveling market. First Irvine location will be located at the Irvine Inn. Farmers Market vouchers are now available at Lakeview Senior Center to seniors meeting income eligibility requirements.

B. Health and Nutrition

Senior Council Member Woollett reported statistics for City of Irvine nutrition programs and recent survey results.

C. Housing and Transportation

Member Kondru reported Orange County Council Senior Transportation Authority staff provided a presentation on the Orange County Street Car project. Six street cars will run 10 minutes apart from the Santa Ana Regional Transportation Center to Harbor The Boulevard/Westminster Avenue in Garden Grove. groundbreaking will occur in October 2018, with an estimated project completion in summer 2021.

D. Legislative – No report.

3. Senior Citizens Council Committees

A. Facilities Committee

Councilmember Kondru reported the shade structure project at Trabuco Center is scheduled to be completed by the end of the calendar year. Cushions for the Lakeview Senior Center patio furniture have been selected and are in the purchasing phase. Improvements to the Lakeview and Rancho Senior Center fitness centers were approved by City Council.

B. Leadership Committee

Vice Chair Ranjbar reported a photo day will be scheduled soon for all the clubs and groups. The Lions Club has provided donation boxes at the three senior centers to collect unused prescription eye glasses. Effective July 2018, the suggestion donation for non-seniors under 60 visiting the Rose Garden Café will be \$5.25 and home delivered meals will be \$6. IKEA has identified many homebound seniors within the Korean community and has begun a home visitation music program.

C. Nutrition Committee

Chair Inmon encouraged Rose Garden Café patrons to show more gratitude to the servers, as they are volunteers and not paid for their service. The Meals on Wheels program is in need of volunteer drivers.
