1. Aquatics Reservation Policy (Policy) Update – The proposed Policy will be presented to the Community Services Commission on May 2, 2018 and will include removal of fee waivers for lifeguarding fees.

- 2. Aquatics Updates
 - Activities advertised through Irvine Unified School District and City marketing materials may only include activities conducted at the City aquatics facilities.
 - Display of banners require a City permit, however banners for non-City events are not permitted to be displayed at City facilities or property.
 - City staff will be responsible for covering and uncovering pools beginning in the fall.
 - Blue lines have been painted in the "No Canopy" areas under the office located on the second floor of the William Woollett Jr. Aquatic Center (WWAC). Groups will be advised to have their participants store personal belongings in this area during group usage of space.
 - A permanent shade structure will be installed on the Instructional Pool deck between May 14 and 18.
 - Renovation of the WWAC locker rooms is still moving forward.
 - Multi-purpose pool heaters will be installed between April 26 and May 4.
 - The pool pump at Northwood Aquatics Center is scheduled for replacement on May 7.
