3. TRIPS Program Update

Community Services Superintendent Sandra Salcedo provided an update on the TRIPS Program.

Superintendent Salcedo made the following announcements:

- The Senior Services Strategic Plan Update was approved and adopted by City Council at the February 12 meeting. Superintendent Salcedo thanked Chair Inmon and Senior Council Member Owens for presenting with staff, as well as Vice Chair Ranjbar, Irvine Korean Evergreen Association President Kim, Irvine Evergreen Chinese Senior Association Co-President Chang, and NEDA President Fathi for attending the meeting in support of the Plan Update's adoption.
- The Rancho Senior Center Fitness Center Dedication will be held February 22 from 12 to 1 p.m.
- The Los Olivos Community Park Opening and Community Center Dedication Event is scheduled for Saturday, March 2 from 4-6 p.m.
- The City is hosting Community Budget Neighborhood Meetings to allow residents input in the development of the City's long-term financial planning as it transitions to a two-year budget, developed in the context of a comprehensive five-year financial plan.

1. Senior Services Support/Interest Groups

A. Irvine Adult Day Health Services (IADHS)

Executive Director Kimberly Beeson reported IADHS presented their request for Community Development Block Grant Funding to the Community Services Commission on February 20. Funds requested are to support Registered Nurse and Certified Nurse's Assistant hours for provision of care. Director Beeson thanked the Friends of Outreach for a \$2,000 donation in support of scholarships for IADHS participants.

B. Irvine Evergreen Chinese Senior Association (IECSA)

Director Jerry Chang reported February was a busy month with two successful events occurring. The February 13 and February 16 Chinese New Year events had great attendance with 270 and 300 guests, respectively. Director Chang thanked staff for their assistance with these programs. The Irvine Multicultural Association Exploring Our World Series event on March 6 will focus on Chinese culture.

C. Friends of Outreach (FOO)

President Pat Hendee reported participation in the Bingo program is averaging 70-80 participants per week, with an average weekly intake of \$530. The International Crafters cart sales are doing well, and the group has started working on 2019 holiday gift bags. There was a restaurant fundraiser at Stonefire Grill on February 15, and another is scheduled at the Ruby's Diner in Woodbridge on April 11.

D. Irvine Senior Travelers

Representative Natalie Chaikin reported the many excursions at the end of 2018 closed the year out successfully. 2019 started with the Annual Travel Show that had over 300 attendees. A day excursion to Palm Springs to see the play Duets took place on February 20. The Senior Travelers Board is seeking interested parties to serve on the Board.

E. NEDA-Association of Iranian American Seniors (NEDA) - No report.

Program Coordinator Amber Castrey announced the Nowruz Iranian New Year celebration will be held on March 14 and tickets are \$25.

F. Irvine Korean Evergreen Association (IKEA)

President Juneu Kim reported IKEA donated a 55-inch television to Lakeview Senior Center that has been installed in the auditorium.
