#### **RECOMMENDED ACTION**

Recommend the Community Services Commission appoint Jennifer Kim to serve as Irvine Residents with Disabilities Advisory Board Member commencing August 6, 2019.

#### EXECUTIVE SUMMARY

The Irvine Residents with Disabilities Advisory Board (Board) provides advocacy and support for programs serving persons with disabilities, assesses community needs, provides appropriate recommendations to City departments, and works collaboratively with organizations within Irvine and the surrounding area that have an impact on Irvine residents with disabilities.

In accordance with Board Bylaws Article IV, Section 1, Members, membership shall not exceed 14 members. The Board currently has one vacancy. A recruitment to fill the vacancy was initiated on April 1 and closed on April 22, 2019. A total of seven applications were received and seven applicants were interviewed.

A Selection Committee comprised of Board Members Kay Kalra and Dennis Niggl conducted candidate interviews on April 25, 2019. The Selection Committee recommends the appointment of Jennifer Kim to the Board. The Community Services Commission has the authority for final approval and appointment.

#### ANALYSIS

There was an open recruitment April 1 through 22, 2019 to fill one vacant Board position. The recruitment was advertised by means of a City of Irvine press release, on the City website, and through Board member outreach. Seven applications were received and seven applicants were interviewed on April 25, 2019.

The Selection Committee rated applicants on their experience and awareness of disability-related issues and their ability to assess, articulate, and advocate for the concerns and needs of persons with disabilities. The Selection Committee recommends the appointment of Jennifer Kim.

The Selection Committee selected the candidate that had the most experience and awareness of disability-related issues and that would be able to assess, articulate, and advocate for the concerns and needs of persons with disabilities. The candidate was selected based on her connection to and advocacy for the disabled community. Ms. Kim is an active member of the Down Syndrome Association and the Special Education Community Advisory Committee for the Irvine Unified School District. She also attends regional, state, and national conferences in the area of disability advocacy and social inclusion. Ms. Kim's background and experience are closely aligned with the Board's goals.

The recommended candidate's profile is presented as Attachment 1, and applications for all candidates are presented as Attachment 2.

### ALTERNATIVES CONSIDERED

- 1. The Board may choose not to forward the recommended appointee and choose an alternate candidate to recommend to the Community Services Commission for appointment.
- 2. The Board may request a new recruitment process.

#### FINANCIAL IMPACT

Board members serve as volunteers and funds to support Board activities are identified in the General Fund Budget. There is no budgetary impact for Board member recruitments.

Dear Board Members,

My name is Jennifer Kim. This letter of intent supports my application to serve in the currently vacant seat of the Irvine Residents with Disabilities Advisory Board (IRDAB).

I am a mother of a young child with a disability. My husband, Peter, and I have worked hard to care and advocate for our son, so that he will grow up with dignity and skills that will allow him to be a contributing member of our community. I am applying for IRDAB so that I can help the Irvine Community Services Commission to better understand the needs and supports that would benefit resident families, who have young children with disabilities and special health care needs.

The recent Disabilities Services Needs Assessment for the city that was reported on February 2018, indicated that more than half (53%) of the caregivers of children ages 0-5 years old felt that the lack of programs/services for their age group was a potential barrier to participating in city-funded community programs and services. Moreover, focus groups that targeted caregivers of young children ages 4-7 years, reported the concerns of only five parents. Improving communication and dissemination of information between city departments and the families of young children with disabilities is essential for addressing disability service needs of this sector of the community, and helping these young children to be included and active residents of their city.

I have been trained as a research scientist in molecular biology at the University of California, Irvine. I currently work as a technical specialist overseeing the Molecular laboratory at CHOC Children's, a pediatric hospital of Orange County. I am an active member of the Down syndrome community and the special education Community Advisory Committee for Irvine Unified School District. My family and I also communicate regularly with families that are part of the visually impaired, and rare disorders communities. I attend regional, state, and national conferences in the area of disability advocacy and social inclusion. The unique skills that I will bring to IRDAB are a meticulous, analytical mind, knowledge of current practices and issues facing the disability community in California, and a team oriented approach to discussing and advising on disability issues. I also represent and bring the perspective of families with young children with disabilities and special health care needs.

Thank you in advance for your consideration of my application to serve on the IRDAB committee. I look forward to an opportunity to share more in regards to applying for this position.


