- Adolescent issues







PRESENTATIONS

- 1. City Clerk Molly Perry provided an overview of the Ralph M. Brown Act, which governs meetings conducted by local legislative bodies.
- Senior Planner Kathleen Haton discussed the Heritage Community Park Improvements Master Plan, which will focus on enhancing the services and facilities provided within the 44-acre community park. Input from Committee was gathered as part of a community input process designed to shape recommendations and prioritize decisions about the park.

Committee input included: the importance of providing facilities for middle school students and teens; the popularity of the library and the water features; parking issues; updates to existing buildings such as the Fine Arts Center, the Community Center and the space occupied by the Irvine Community Nursery School; the appeal of the park as a multiuse site for children and adults of various ages; and preferences regarding the pond.

ANNOUNCEMENTS

Co-chair Johnson-Norris welcomed the group back for its first meeting of the calendar year and briefly reviewed the key areas of the Committee's proposed work plan.

Manager Loughrey announced the following:

- The City, in partnership with the Irvine Prevention Coalition, is hosting a parent forum on Wednesday, March 27, 2019, from 6 to 8 p.m. at Irvine Civic Center. The forum entitled "Staying Connected to Today's Teen: The Foundation of Better Mental Health and Well-being" will feature licensed clinical psychologist Dr. Jerry Weichman. Dr. Weichman will discuss the impact of positive social relationships on teenager's mental and physical health. A flyer was handed out to the Committee.
- The Irvine Prevention Coalition is holding its Outstanding Supporters of Prevention Awards on Wednesday, May 8, 2019, from 5:30 to 7:30 p.m. at Irvine Civic Center. Committee members are encouraged to nominate individuals or groups who have helped to create positive outcomes for children and families in Irvine. Nomination forms were distributed to the Committee.

• The High School Youth Action Team is hosting its 25th Annual Teen Summit on Saturday, March 2, 2019, at Lakeview Senior Center. Approximately 400 students are expected to attend the event and participate in a variety of educational workshops and activities.
