CITY COUNCIL RESOLUTION NO. 19-35

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF IRVINE, CALIFORNIA, ESTABLISHING FEES FOR SERVICES RELATED TO PUBLIC SAFETY, REPLACING AND SUPERSEDING ALL PREVIOUS RESOLUTIONS THAT ARE INCONSISTENT THEREWITH

WHEREAS, there are a number of services provided by the City's Public Safety Department such as duplicating reports and photographs; issuing a variety of permits and licenses; animal service fees; and charges in the City that are of primary benefit to the applicant or member of the public; and

WHEREAS, the cost of these services should be borne primarily by the applicant or member of the public receiving benefit from such services; and

WHEREAS, the City can account for the actual costs of these services provided to the applicants; and

WHEREAS, the City has conducted a cost study to determine the actual cost of providing various Public Safety services, recommending modifications to the City's existing fees to reflect the actual cost of providing these services; and

WHEREAS, the City Council conducted a duly noticed public hearing on May 14, 2019 to consider the proposed fee modifications.

NOW, THEREFORE, the City Council of the City of Irvine DOES HEREBY RESOLVE:

SECTION 1. Amount of Fees

Based on the evidence presented to it, the City Council finds the fees adopted by this Resolution do not exceed the reasonable cost of providing the services for which the fees are charged.

The fees for services related to the Public Safety Department shall be based on the actual supply cost of providing the service. Staff time for these types of services is not recoverable by law. Applicable fees are detailed in Exhibit A incorporated herein by this reference as it sets forth in full.

SECTION 2. Waiver of Fees

The City Manager or the designated administrative authority may approve or waiver fees under the following circumstances:

- 1. Where the applicant is a nonprofit organization formed and operating for eleemosynary, civic or educational purposes; or
- 2. Where the actual cost of processing an application is considered to be negligible.

SECTION 3. Annual Increases

The City will conduct a full cost and fee analysis, and revise fees based on the result of the analysis, every two to three years. In years when a full cost and fee analysis is not conducted, fees indicated by an asterisk (**) may be adjusted annually to reflect the increase in the Consumer Price Index for the Anaheim/Long Beach area. Fees for duplicating of documents and records may be adjusted annually to reflect actual materials costs. Fees set by statute may not be adjusted by the City. The proposed fees along with the supporting data and calculations will be presented to the Finance Commission for review and City Council at a public hearing for review and action.

SECTION 4. Effective Date

The revised fees shall be applied to all invoices submitted or processed beginning July 1, 2019.
