1. SELECTION OF CHAIRMAN OF THE SUBDIVISION COMMITTEE

3. VESTING TENTATIVE TRACT MAP 17997 FOR BLUE BAY CONDOMINIUMS LOCATED AT 2602 MCGAW AVENUE IN PLANNING AREA 36 (IRVINE BUSINESS COMPLEX)

Committee Member Chao noted that SECTION 4 of the resolution should reference the IBC Vision Plan EIR and that Condition 1.13 should read Director of Public Works, not Community Services.

5. VESTING TENTATIVE TRACT MAP 19004 FOR NEIGHBORHOOD 1 OF PLANNING AREA 1 (ORCHARD HILLS)

Jason Liu, resident, expressed concern regarding the construction of additional homes in Orchard Hills due to existing unsafe traffic congestion, specifically on morning school days. Member Murillo went over the approval process noting the police department and traffic engineers had reviewed the map and felt that other than the usual early morning drop of children there were no traffic deficiencies. The Irvine Company was also contacted and realizes that school drop off times are difficult and noted that their Civil Engineer was available to answer any questions.
