Approve the revised Irvine Residents with Disabilities Advisory Board 2019 Meeting Schedule.

EXECUTIVE SUMMARY

The Irvine Residents with Disability Advisory Board (Board) mission is to identify and recommend programs and services that would meet the social, physical and emotional needs of residents with disabilities, regardless of age.

Each year the Board sets an annual meeting schedule as required by Board Bylaws to conduct the Board's mission and purpose. The 2019 meeting schedule was approved by the Board at its November 6, 2018 meeting. Since that time, the Disability Services Program has relocated its offices from the Irvine Civic Center to the Sweet Shade Community Center (Sweet Shade), located at 15 Sweet Shade, Irvine. Sweet Shade offers ideal meeting space for Board meetings. Therefore, staff is requesting the Board's consideration in changing the location of Board meetings to Sweet Shade beginning with the September 2019 meeting. A revised 2019 Meeting Schedule noting the change in meeting location is provided as Attachment 1 for the Boards review and approval.

ANALYSIS

At its November 6, 2018 meeting, the Board approved the 2019 meeting schedule with meetings to be held at the Irvine Civic Center. With the transition of the Disability Services program to Sweet Shade, staff is recommending the Board consider conducting their regular meetings at Sweet Shade rather than the Civic Center. Sweet Shade offers accessible meeting space ideal for Board meetings.

A revised 2019 Meeting Schedule is proposed to reflect Sweet Shade as the official meeting location for Board meetings, beginning with the September meeting. Board meetings are held on the first Tuesday of designated months at 6 p.m., unless otherwise noted. The revised 2019 Meeting Schedule is presented for Board review, discussion, and approval.

ALTERNATIVES CONSIDERED

The Board may choose to not change the location of Board meetings and continue meeting at the Irvine Civic Center, or recommend an alternative location for Board meetings.

FINANCIAL IMPACT

There is no financial impact to approving the revised meeting schedule for 2019.
