Description

Phase 1, Part 1: Site preparation and demolition: Phase 1 of the project (approximately 24 acres) will include the demolition of features within the 100-acre site. Demolition includes existing utilities and their support structures, and storm drains. Demolition of the airfield pavement and airfield utilities (eg, lighting), and removal of those materials is the responsibility of others and therefore not in the scope of work for the State. Phase 1, Part 2A: New Construction: New construction of the cemetery which encompasses approximately 24 acres of the property and includes rough and fine grading; utility trenching and installation; paving of drive aisles and access roads; landscape planting and irrigation; interim storm drainage inlets; stormwater treatment basin; off-site storm drains; development of 7,864 in-ground cremain plots; 4,160 columbaria niches; 6,920 pre-placed double depth concrete crypts, and 80 pre-placed double depth oversized concrete crypts; administration and public restroom buildings (2,045 sf); maintenance building (2,744 sf) and paved maintenance yard (57,500 sf); ceremonial entrance and cortege assembly area for thirty (30) automobiles; committal service shelter (1,802 sf); flag/assembly area, and memorial walk and memorial wall; signage and flower water stations; and off-site public roadway and underground utilities along a portion of the site frontage. Part 2B: New Construction of the main entrance and maintenance access gates, perimeter walls and fences for the entire 100-acre site.
