- The reception for an exhibition highlighting the works of long time City photographer David Kawashima will be this evening in the Civic Center lobby from 5 to 7 p.m. and is open to the public.
- In commemoration of "National Employ Older Workers Week," the Orange County Mobile Workforce Unit will be in the Lakeview Senior Center parking lot on Thursday, September 23, from 10 a.m. to 2 p.m. to provide direct employment services to seniors interested in rejoining the workforce. A variety of services will be offered, including job recruitment, skill training, continuing education coaching, and résumé assistance.
- The Senior Council Member-at-Large Recruitment is open and will close at 4 p.m. on Friday, September 24. Interviews will be held on Thursday, September 30 at Lakeview Senior Center.
- The 20th Irvine Global Village Festival will be held at the Great Park on Saturday, October 9, from 10 a.m. to 7 p.m. This annual festival includes kids' activities, local and global cuisine, an artisan's marketplace, music, art, and exhibits. Admission and parking are free, but premier parking closer to the festival site will be available on a first-come, first-served basis for \$10 on-site, cash only. Food samples will also range from \$3 to \$5, depending on vendor and payable directly to vendor.

A. Friends of Outreach:

Senior Council Member Jacobs reported the Bingo program will resume on October 5 in the Lakeview Senior Center auditorium.

B. Irvine Adult Day Health Services, Inc. (IADHS)

Kimberly Beeson, Executive Director, reported the following:

- Advancements have been made in in-service care and support, starting in July
- Attendance has increased each month since then
- Working toward increasing traditional services safely
- Annual fundraising campaign event will be done virtually, will hold in-person gala when more feasible
- City of Irvine has committed to a \$20,000 match sponsorship, and \$53,000 has been raised to date (goal is \$150,000)
- IADHS' new website will be launched soon
- C. Irvine Evergreen Chinese Senior Association (IECSA):

Jerry Chang, IECSA President, reported the annual Moon Festival will be held on September 18, from 10:30 a.m. to 1:30 p.m. and will include a catered lunch, entertainment, and distribution of moon cakes.

2. Orange County Senior Citizens Advisory Council-Affiliated Committees

A. Orange County Senior Citizens Advisory Council (SCAC)

Chair Inmon reported a federal award of 4,000 iPads were provided to the state, 300 of which will be allotted for Orange County seniors. SCAC has developed a proposal to implement this senior technology program that will provide seniors with devices that include connectivity as well as a class, "Get Set Up." Plans for distribution of devices are still being developed.

B. Health Re-imagined:

Senior Council Member Chang reported a presentation was given on skin cancer awareness, prevention, and treatment. Senior Council Member Baradehi reported on statistics given regarding skin cancer and also reported that SCAC subcommittees are still working through reorganizations.

C. Housing/Transportation

Senior Council Member Chang reported information was shared about the Be Well Campus and services provided, and that COVID-19 vaccination booster rollout plans were a topic of discussion.
