# Transitional Kindergarten (TK)

• The Kindergarten Readiness Act 2010

- Changed Kindergarten age eligibility cut off from December 2 to September 1
- Mandated districts to offer TK for students who were affected by the change



# **Current Age Eligibility**

• Children who turn 5 years old

between September 2 and December 2 – Transitional Kindergarten

On or before September 1 – Kindergarten



# Senate Bill 130 (SB 130) & Assembly Bill 130 (AB130)

• Expand Transitional Kindergarten to all four-yearolds, regardless of income eligibility School District programs only Expansion beginning 2022-23 school year, children who turn five between September 2 and February 2 Full expansion to all four year olds will be achieved by school year 2025-26





# Purpose

- To increase access to early education
- To close achievement gaps



 Access to at least one year of high quality, developmentally appropriate pre-kindergarten early education for all four year olds in California





## **IUSD** Implementation

### IUSD's Communication to Date:

- 1. The CA Department of ED has proposed some changes to TK starting next year.
- 2. These changes have NOT yet been finalized.
- 3. At this time, the state has proposed that the window for TK for the 2022-2023 school year is for students turning 5 between Sept. 2 and Feb. 2 (this year was Sept 2 to Dec 2).
- 4. However, this is still subject to change.





# IUSD Implementation of "part-time" TK Program

The phase-in model begins in the 2022-23 school year with following age eligibility for children enrolling in Transitional Kindergarten.

- 2022-23: 5<sup>th</sup> birthday between September 2 February 2
- 2023-24: 5<sup>th</sup> birthday between September 2 April 2
- 2024-25: 5<sup>th</sup> birthday between September 2 June 2
- 2025-26: 4<sup>th</sup> birthday by September 1st



# **IUSD** Implementation - Communication

IUSD begins community communication regarding TK and K in February 2022. At that time, we will have more concrete information to share regarding changes (w/ specifics) to TK in IUSD for the 2022-2023 school year.

1. START WELL, MENTAL HEALTH CONSULTATION FOR EARLY CARE AND EDUCATION – Sandy Avzaradel, Director of Start Well, provided an introduction and overview of the program designed to support center-based and family child care programs struggling to support children's challenging behaviors.

- Solis Park K-8 School will be opening in August 2022 in the Heritage Fields, Great Park area. A call for proposals for the before- and after-school care provider at the school site will open in November.
- The Child Care Provider Appreciation events have been postponed to the new year due to delays in getting access to giveaway items from sponsoring companies due to the pandemic. Event information will be provided when it is available.
- Early Childhood Investigations is presenting "Big Questions, Worries, and Fears: How to have hard conversations with little children" for early childhood professionals on October 13, 2021 at 11 a.m.
