## One Irvine – FREQUENTLY ASKED QUESTIONS

### 1 What is the One Irvine Program?

One Irvine is a neighborhood revitalization program that connects Irvine residents with community strengthening resources, and with each other. One Irvine focuses resources in Irvine's older neighborhoods to spark community-led reinvestment. The program offers a citywide Permit Fee Holiday, Residential Rehabilitation Program (RRP), as well as Green Home Grants and Home Improvement Loans to owners of qualifying single-family homes and condominiums built in or before 1980.

### 2 What is the Permit Fee Holiday and how can I sign up for it?

The Permit Fee Holiday is a citywide program that waives up to \$1,500 in fees per household. The fees are specific to certain building and planning fees for all single-family homes and condominiums built in Irvine in 1980 or earlier. ### 3 What is the Residential Rehabilitation Program (RRP)?

The Residential Rehabilitation Program is available to residents citywide and offers financial assistance through 3% interest deferred loans and emergency grants to assist low-income homeowners with critical home improvements. Homeowner assistance is offered for health and safety, building code, and accessibility-related repairs. ### 4 What is a Green Home Grant?

A Green Home Grant allots up to \$1,500 per household to support smaller sustainability projects. Funding for this program is limited, for more information and to access the pre-application, visit [cityofirvine.org/oneirvine](http://cityofirvine.org/oneirvine).

### 5 What is a Home Improvement Loan?

A Home Improvement Loan allows up to \$25,000 for larger-scale projects to owners of qualifying single-family homes and condominiums built in or before 1980. These loans, repaid upon sale or transfer of the property, are designed for projects related to critical repairs or sustainability, including solar panels. Funding for this program is limited, for more information and to access the pre-application, visit [cityofirvine.org/oneirvine](http://cityofirvine.org/oneirvine). Owners that have a reverse mortgage loan are ineligible for the Home Improvement Loan.

### 6 If I am on the Green Home Grant or Home Improvement Loan waitlist, what are the next steps?

### 7 Do I need to be an Irvine homeowner to apply to the One Irvine program?

Yes, the applicant must be the owner of record of a single-family home or condominium or the owner's legally-appointed representative. The home must also be owner-occupied to qualify for the program.

### 8 What are the requirements to become a contractor with the City of Irvine?

The requirements include a unique Entity Number, workman's compensation insurance and listing City as additionally insured, business license, member of CSLB.

### 9 How do I check if my contractor is licensed with the City of Irvine?
