

- Parents choose the values, skills and behaviors to encourage in children
- Foundations for social and emotional skills are laid in the early years
- Children are more likely to:
  - Develop confidence
  - Reach their potential
  - Get along with others

# BUILDING BLOCK 1: SHOWING RESPECT TO OTHERS



- Children demonstrate respect when they
  - Speak politely
  - Use appropriate name and titles
  - Cooperate with requests and instructions
  - o Follow rules in different setting (home, school, and classroom)
- Encouraging politeness
  - Being the role-model
  - · Prompting child to ask politely
  - Praise child when they are polite
  - Do not give the child what they want when they ask in a rude or unpleasant way

# COOPERATION

- Being cooperative means:
  - Stop what they are doing
  - Listen and understanding what is being said
  - Following through with instruction given
  - Cooperate with others
- Encouraging cooperation:
  - Get close
  - Use the child's name
  - o Give the instruction clearly in a calm, firm voice
  - Pause (5 seconds)
  - o Praise child if they do as you ask
  - Repeat the instruction once if necessary
  - Back up the instruction with a suitable consequence



# BUILDING BLOCK 2: BEING CONSIDERATE



## BEING CONSIDERATE HELPS

- Children find it easier to make friends and get along with others if they:
- Listen
- o Let others have a turn
- Ask what others would like to do
- Wait while others are busy

- Think about others' feelings
- Help others
- Are friendly and welcoming
- Help out at home

# ENCOURAGING CONSIDERATION

- Being a role-model
- Avoid criticizing others
- Focus on the positive
- Helping others showing kindness
- Acknowledge child for being kind and helpful
- Ask child how their actions make others feel
- Provide consequence for inconsiderate or hurtful behavior



Building Block 3: Having Good Communication AND Social Skills



# HOW SOCIAL SKILLS HELP

Children who develop good social skills:

- Find it easier to make and keep friends
- Are liked by their peers
- Get along well with others
- Have less conflict with others

# ENCOURAGING FRIENDSHIP:

- Show an interest in a child's friends and their family
- Talk about what it means to be a good friend and what healthy friendships are
- Suggest meeting child's friends
- When child socialize with others expect appropriate behavior
- Provide consequences for misbehavior



# if the child hurts others:

- Understand what child has done
- Discuss incident with child and hear their explanation of the incident
- Remind child that hurting others is a problem and do not minimize incident
- Discuss how their actions/behavior affect others
- Explain the consequences for hurting others
- Being aware of how child interacts with others
- Praise child for playing well with others
- If problem occurred at school, encourage parent to work with school



BUILDING BLOCK 4: HAVING A HEALTHY SELF-ESTEEM



# CHILDREN WITH HEALTHY SELF-ESTEEM

- Children with healthy self-esteem often:
  - Are happy
  - Cooperate
  - Succeed
  - Make friends easily
- Children with low self-esteem:
  - Feel inadequate
  - Are reluctant to trying something new
  - Give up easily



# POSITIVE SELF-ESTEEM

Children's positive self-esteem is influenced by:

- Thinking and believing in themselves
- Receiving lots of praise, affection, and attention from parents
- Having achievements recognized
- Having clear limits and appropriate discipline



# LOW SELF-ESTEEM

Children from low self-esteem may result from:

- Unfavorable comparisons with siblings or peers
- Lack of self-care and hygiene
- Lack of physical activity and low fitness levels
- Poor body image or being overweight
- Negative thinking
- Negative environment at home (domestic violence)
- Neglect or abuse



# BUILDING SELF-ESTEEM

- Create a safe, predictable environment
- Spend time with child doing active and enjoyable things
- Be affectionate say "I love you"
- Encourage child to set realistic goals for themselves & teach child to see their accomplishments
- Help child be a good friend
- Encourage child to express their ideas
- Encourage laughter
- Let child to make decisions when appropriate

## HOW PROBLEM SOLVING HELPS

- Important life skill
- Problem-solving skills are related to
  - o Personal development, self-esteem and confidence
  - School work and academic learning
  - Skills in other areas (sports)
  - Social development and relationships

# HELPING PORBLEM SOLVE

- Set a good example
- Play games that promote thinking
- Encourage child to find answers
- Prompt child to work at solving problems
- Praise them for solving a problem on their own
- Involve them in family problem solving



# PROBLEM SOLVING STEPS:

- Define the problem
- Come up with solutions
- Evaluate the options
- Decide on the best solution
- Put the plan into action
- Review how it worked and revise plan if necessary

# HOW INDEPENDENCE HELPS

Learning to be independent help children:

- Prepare for later life
- Participate in family life

Becoming independent involves:

- Learning basic self-care skills
- Increasing responsibilities
- Feeling confident in their abilities

# SHOWING INDEPENDENCE

Behaviors that show independence include:

- Getting ready to go out
- Completing simple house chores
- Self-care skills (using toilet, brushing teeth, dressing self)
- Looking after their own belongings
- Picking up after themselves
- Getting ready for school



# TAKE-HOME MESSAGE

- The values, skills and behaviors to encourage are the choice of each parent
- Some core skills are the building blocks to help children:
  - develop confidence
  - reach their potential
  - o and get on well with others
- Parents can encourage children to develop their skills



# TAKE-HOME MESSAGE

- Encourage your child to show respect
- Encourage your child to be considerate
- Help your child become a good communicator
- Help your child develop self-esteem
- Teach your child to problem solve
- Encourage your child to take responsibility and do things for themself

#### RECOMMENDED ACTION:

Discuss, deliberate, and take action if needed regarding emailed public comments regarding alleged social media posts by Housing & Community Development Commission member received in connection with Housing & Community Development Commission meetings held on August 25, 2022, and September 22, 2022.

## AB 361 (Government Code § 54953(e)(3) Review and Findings Julia Bidwell, Executive Director/Secretary

Hello I sent this email but it never arrived so I am sending it again because I now see that James Mai's stalker/harasser, Mary Cameron, under her many aliases - Bettina Bakrania, Love Cameron, Cory Ng, Melissa Foster, etc., has escalated her harassment and threats by contacting committee members and their employers to spread blatant lies, harass, an threaten them. She has committed slander on Facebook, falsely stating that committee members are abusing children of color. This individual, Mary Cameron, is a criminal and is clearly unstable and dangerous. Her actions and criminal history prove she is a threat and actions need to be taken to ban her so she cannot cause further disruption and potential physical harm to innocent people in the City of Irvine.

#### Hello,

I am writing to share about my personal and professional experiences with James Mai as a counter to the portrayal of him by his accuser, Ms. Cameron, a woman who, despite having had limited interactions with Mr. Mai over a short period of time, has formed an opinion of him and his character that is in direct opposition to the person I have known and worked with for over five years.

I first met James Mai in November 2017, I'm a single mom and a credentialed Education Specialist and I responded to a job posting for a part-time copywriter, hoping to supplement my income, and that is how I met James Mai. I met with him to discuss his needs and we had a great conversation. Ultimately, I couldn't fully commit to the entire job, but said I was open to any short-term projects that he needed help with, as they came up, and we agreed to stay in touch. Over the next few months, we'd chat on occasion and gradually developed a friendship. At the time, his childhood best friend, Aaron, who was like a brother to James, was dying of a brain tumor. James shared with me that he had started a GoFundMe for him, and raised over \$50,000, which allowed Aaron and his wife to spend the final months of his life free from financial worries, focusing on what mattered without worrying about paying their bills. I'm not sure many people, other than Aaron and his wife, really understand what an impact that made on his friend's last days, because I got the sense that no one really thanked James for it. And I imagine that's because James didn't advertise what he had done. He didn't brag about it all over social media, or tell everyone in his hometown, he just did it, because that's what he does

for people who need help. If he sees a need and there's something he can do about it, he does it. And it's not always financial, or political, it's not always the stuff you've been seeing him do on the news or at events. Sometimes, it's more subtle, sometimes he helps you, just by being your friend, getting behind you and supporting whatever it is you're doing, and being your biggest hype-man. He does everything 1,000% and that includes cheering others on.

James was raised by a single mom and experienced the struggles that unfortunately come with that. He loves this country because it gave him the freedom to move beyond the limitations of his childhood circumstances and he wants everyone to have the opportunity to do the same. He has a soft spot for the underdog, but it doesn't come from a place of condescension, and he doesn't have to feign empathy by pretending to tolerate those who are struggling. He's not saying I want to help you because I can imagine what it must feel like to struggle like you, he's saying I want to help you because I HAVE struggled like you. And even though, with hard work and determination, he was able to overcome the circumstances life dealt him with little to no resources or support, he understands that not everyone has the natural skills, motivation, and personality to pull themselves out of a negative situation alone. And that's why he does what he does. You know about James Mai, today, because of the work he does gathering resources and rallying his community to unite and support each other in order to ensure that everyone, whether they are disadvantaged, marginalized, or experiencing temporary hardship, has the resources and support they need to get a jump on living their best possible life with safety, dignity, and respect.

I have been following the public attack on James' character perpetrated by Ms. Cameron and, while I find her claims and relentless pursuit to destroy him and his family appalling and frightening, I understand that she is mentally ill and delusional. What is equally, if not more appalling and frightening, is the willingness of so many individuals who, considering their professional and leadership positions in the community, I would expect to be highly educated, reasonable, and fair, are 100% ready and willing to believe and support one person's twisted account of a single occurrence without any attempt to step back, look at the big picture, and ask the simple question, "Does this make sense?" So, I'll ask you, does any of this make sense?

You don't need to know all the facts or specifics to see that it doesn't make sense at all. There are two sides here. On one side, James Mai is a community activist, business owner, husband, father, and a productive citizen of the city of Irvine with a track record of philanthropy and support for the most vulnerable members of the community he lives in. On the other side, is his accuser, a verified litigious provocateur and criminal with a known history of vandalism, who had no connection to Mr. Mai when she decided to make him the target of her latest smear campaign. Speaking of smearing, and an example of the mental state of this woman, she was caught on video smearing her own feces all over her last residence when her complaints about noise didn't get the response from management she wanted. Her response to their perceived lack of interest in indulging her delusions? She's suing them. Just like she has sued most people, businesses, and organizations she has encountered throughout her life. I won't go through her entire rap sheet because it's quite long, I'm just giving some minimal background information, all of which is easily accessible to anyone who takes 5 minutes to do a google search.

So, again, my question is, does this make sense? Whose story is out of character and who's is consistent with their lifelong behavior? James Mai, with his proven contributions to society, political work, and community support, and his record as a long time business owner and family man, or a woman with a proven documented history of exactly these type of malicious, delusional attempts at manipulation, gaslighting and criminal behavior, which has now escalated to literal death threats, as she recently posted on social media, an image of a man holding a shank along with the comment that Mr. Mai needs to be taken out, "permanently?" It's plain to see that what Mr. Mai's is being accused of by this individual, is not consistent with his history and it's not consistent with the man I've come to know for the past 5+ years, while the documented pattern of his accuser's behavior is, yet she seems to get immunity simply because she is perceived to be the less powerful of the two parties. It's sad to see seemingly intelligent people appear to be more concerned with looking politically correct than actual logic and facts.

We all have bad days. We all say things that get taken out of context, that we didn't mean, or that we straight up shouldn't have said and regret. No one is perfect, including James Mai. He is definitely a passionate man who can appear intimidating, but anyone who has given him just a few minutes of time will tell you he is a kind, funny, family man who has the integrity to stand up and take action for the causes he believes are in the best interest of his family, friends, neighborhood, city, state, and country or any other individual or organization with a need he can help fill. Don't mistake his passion and enthusiasm for arrogance or ego, and don't judge his character from one person's interpretation of a single incident no one, other than the two people involved, will ever know the facts, context, and true intentions of, because no one else was there to witness what led up to it. Instead, look at the big picture and the track record of the many things James Mai has contributed to his community and the lives of those he cares about. That is who James Mai is. As for the accuser's character, her track record, as well as her arrest record, speaks for itself, and the writing is smeared on the wall.

To Whom it May Concern:

James Mai is on the Child Care Committee for the City of Irvine. This is problematic because social media posts by Mai himself reveal that he committed a Hate Crime.

Mai has never disputed that he made the posts, and even admitted to Irvine Police that screenshots showing him bragging in detail of how he committed the Hate Crime were real.

In the Instagram posts. Mai gives a motive. He claims the owner refused to refund his credit card after being overcharged. The atrocious story ends with Mai gloating that he had received a full refund after committing the Hate Crime. The terroristic act got him his desired result Mai makes no secret of how he achieved procuring the refund and has never shown remorse.

The Hate Crime falls under the classification of "Hinduphobia" as it was committed (according to Mai himself) against an Indian restaurant and the owner was Hindu. The cow is sacred in the Hindu belief system, so such an act as committed by Mai is an attack on Hindus. That places it in the category of "Hate Crime"

Beginning after Labor Day weekend, and continuing through October 10th, approximately 100 emails were sent to the Irvine City Manager's office regarding one James Mai. There may have been some phone calls as well. We aren't certain

The emails were sent by local residents who live, work or study in Irvine, ie who had a standing to demand answers from the City. They were concerned citizens who were appalled and outraged that such a person is even allowed to hold an appointed post.

Despite this collaborative effort by members of the community, the City Manager's office failed to turn those emails over to the Child Care Committee members. The City did not even inform the Commissioners of the very existence of these emails, despite the high volume of correspondence about James Mai.

Inexplicably, the City Manager's office further failed to inform Commissioners and members of the Child Care Committee that Mai was under investigation by the FBI for said hate crime. Even more shockingly, they did not disclose that their own police department was investigating James Mai for the same hate crime.

On October 11th, the Child Care Commission met for its regularly scheduled meeting. By that time: Mai had already admitted to IPD that he had bragged on social media of this nefarious crime.

This development was significant as it constituted an official admission by Mai. Still, nobody in the City of Irvine thought it important to notify the Child Care Commission

One of the agenda items for October's meeting was the reappointment of Mai for another two years.

The motion was came on and was passed by majority vote. Mai's term, previously set to expire on Dec 31st of this year; has now been extended for another two years.

We are trying to ascertain if the Committee members who voted in favor would have done so had they known of the voluminous emails sent to the City, or had they known of the existence of the investigation. Most importantly, they weren't informed of the pending investigations nor Mai's admission.

We decided to reach out to some members of the Commission to suggest they clarify with the City of Irvine if they are willing to stand behind their vote, given this new information.

We know that three members would refuse to reconsider even in light of the new information. These are: Donna Schwartz. Myra Firth and Imithri Bodinhayake who pushed and pressured others on the Committee to vote "yes". in spite of evidence presented by a public speaker who is the witness in the Hate Incident.

They are not receiving a copy of this correspondence as it would be pointless and serve no worthy purpose.

Everyone else on the Commission is receiving a copy as we hope this letter will motivate them to press the City for answers. Concerning those Commissioners who represent agencies and educational institutions. We are also sending it to those entities.

At time of writing, the Child Care office is refusing to accept or acknowledge emails where Mai is the subject. This is because the Commission meets again next. Tuesday. Any correspondence sent to them that makes mention of the #JamesMaiHateCrime will not be shared with Commissioners or Committee Members.

For this reason, it was necessary to take this drastic step of making direct contact with involved parties.

This letter is in reference to your October 20, 2022 request under the California Public Records Act (Government Code § 6250 et seq.) for copies of emails sent to <a href="mailto:cm@cityofirvine.org">cm@cityofirvine.org</a> requesting the DEI office to make a finding as to whether the #hinduphobicvandal violated Municipal Conduct on hate speech.

Additional time is required to search for and collect the requested records from field facilities or other establishments that are separate from the office processing the request. Under the California Public Records Act (Government Code § 6253(c) et seq.), an extension of an additional 14 days is appropriate under these circumstances.

the letter is framed in terms of a desire to do diligence.

due diligence is always commendable. giving an incomplete record would defeat the purpose, so this were a bona fide move, based on a desire for transparency and a thorough accounting; it would be acceptable.

#### but i dont think thats whats going down here

see this screenshot: it contains the dates for the **next** child care committee meeting. thats where october's minutes will be up for approval.

the letter you sent me last week goes on to say:

its highly unlikely i will get the requested materials in time for the nov 8th child care committee meeting.

the original basis for the PRA request was to see the volume and content of emails sent to the office of the city mgr from approx sept 7th to approx oct 10th.

thats because i have personal knowledge that a multitude of concerned citizens sent emails questioning why the vandal james mai ( whether mentioned by name or not ) is allowed to hold a commission post.

the foundation for concern was the now ubiquitous post from IG where he brags HE committed a gruesome hate crime.

it is both repulsive and repugnant. it does not in any way reflect positively on the city of irvine

it is an insult to this beautiful, melting pot of a city that exudes multiculturalism and diversity on a global level.

the members of the public who wrote in to the city mgr's office did so because they were outraged by such a brazen display of hatred and bigotry.

it seems obvious that such correspondence should have been shared with the child care committee - that they may hear the voices of the community.

instead: the city mangers office failed to even <u>inform</u> the child care office of the existence of these emailed inquiries.

this, in turn set the stage for a smooth, hassle free reappointment of the vandal on oct 11th.

the question begging is: <u>HAD</u> the city mgr's office turned over those emails to the child care office in a timely manner - or forwarded them in real time

#### - AND -

<u>HAD</u> the child care office employees disseminated these emails to the committee members at least a few days prior to oct 11th: WOULD THE VANDAL HAVE BEEN REAPPOINTED?

i do not believe so.

by giving yourselves additional time well past Nov 8th: the City created total "impossibility":

the emails wont be delivered to me in time for me/others to present them to the child care office in time for committee members to see them, hence the minutes - including the votes on re=appointment will be approved and the vandal receives an extended term of another two years.

if i somehow gotten this twisted, correct me.

but look at the OPTICS of it.

how would each of you - if you separated yourselves from your roles and saw this through the lens of a citizen......how would you perceive this?

how does this not reek of fraud? of subterfuge?

at this stage: i have more pressing needs to attend to - of a personal nature.

What, if anything will the City of Irvine and OC Housing Authority do to prevent the constant doxxing of Cameron by James Mai's allies?

Compare that to Mai's supporters who call in under <u>unverifiable</u> identities and don't even show themselves on camera!

It is unlawful for governmental agencies and entities to disclose the protected personal identification information of a Safe at Home enrollee. I assume this would include taking measures to ensure <u>others</u> don't either, especially during public meetings. All the more so if the commenters can't be verified.

It bears repeating ALL of this is occurring in relation to James Mai. This needs to stop.

Due to Ms Cameron being very upset about this, I offered to try my best to get resolution. If you need proof of Ms Cameron's status as a Safe at Home enrollee, please let *her* know. It's my understanding law enforcement already confirmed it.

Ms Cameron would like immediate preventative steps taken to ensure the government entities involved do not further give a platform for the doxxing of her by trolls acting on James Mai's behalf.

The purpose of public comments are to express one's voice and opinions on any items within the subject matter jurisdiction of the body meeting.
