EXECUTIVE SUMMARY

Irvine Community Alliance Fund (ICAF) is a nonprofit entity that receives and distributes funds, property, and other resources to aid, sponsor, promote, advance, and assist in the charitable provision of public parks, recreation, and community services in and for the City of Irvine and greater Irvine area. ICAF is governed by a Board of Directors consisting of community volunteers and City of Irvine staff representatives.

In accordance with ICAF Bylaws, the Chief Financial Officer of the organization is responsible for records of accounts and preparing the Annual Report regarding the financial condition of the organization.

ANALYSIS

In accordance with ICAF Bylaws, Article X, Section 7(e), the Chief Financial Officer of the organization is responsible for keeping and maintaining adequate and correct books and records of accounts. ICAF Bylaws, Article XII, Section 3, specifies the requirements pertaining to the organization's Annual Report.

At the meeting, the Chief Financial Officer presents a summary report on the financial condition of the organization for the Fiscal Year 2021-22 with prior year comparison information for FY 2020-21 (Attachment).

FINANCIAL IMPACT

The Statement of Contributions and Expenses report for FY 2021-22 shows program contributions of \$40,444.03. This represents an increase of \$20,872.20 from the 2020-21 program contributions of \$19,571.83. Program expenses track with contributions. The contribution increase is primarily the result of \$16,050.00 in contributions from Schwab Charitable Fund, combined with a \$5,081.59 increase in contributions from the Benevity Community Impact Fund.
