STAFF ANNOUNCEMENTS

Amber Castrey, Community Services Supervisor, made the following announcements.

- Senior Services offered a variety of programs and events over the past few weeks. Highlights include: Diwali Festival of Lights serving 175 participants; HICAP Annual open enrollment clinic serving 50 participants; Outreach Services distributed 20 emergency backpacks to participants of the Personal Safety presentation provided by Irvine Police Department; 117 American flags were delivered to Veterans in observance of Veterans Day. In October, Senior Services served over 9,500 participants through over 125 programs among the three senior centers. A full report and upcoming programs were provided as a handout.
- The Irvine 2/11 Marine Adoption Committee Holiday Toy Drive will run through December 14. Collection bins are located in the Irvine Civic Center Lobby, Irvine Police Department Lobby, and the Great Park Visitors Center. The 2/11 Marines will also be on-site on Sunday, December 4 from 9 a.m. to noon at the Colonel Bill Barber Marine Corps Memorial Park parking lot collecting donated items.
- The City's Annual Holiday Tree Lighting Event is scheduled for Saturday, December 3 from 4 to 6:30 p.m. in the Civic Center Piazza. The event will include visits with Santa Claus, live holiday music, and a winter-themed train route. Guests are also encouraged to bring new, unwrapped gifts for the toy drive.

Denise Bennett-Arabatzis, Community Services Supervisor, made the following announcements:

- The Senior Services Holiday Luncheon for Meals on Wheels participants is scheduled for December 7 from 11:30 a.m. to 12:30 p.m. at the Lakeview Senior Center.
- Holidayz at the Park will run from November 19 through January 1, 2023 and will include festive lights, photo backdrops with interactive displays and ongoing activities. Visit the City's website for more detailed information.
- The annual Senior Services Twilight Holiday Social will be held on December 9 from 4 to 6 p.m. at Trabuco Center. The event will include light refreshments and entertainment. Space is limited and registration is required, with a fee of \$10 per attendee.

Interim Director of Community Services

RECOMMENDED ACTION

Designate representatives of Irvine Senior Citizens Council to the Orange County Senior Citizens Advisory Council affiliated committees and the Irvine Senior Citizens Council subcommittees.

EXECUTIVE SUMMARY

Irvine Senior Citizens Council (Senior Council) serves as an advisory body to City Council on policy matters affecting older adults and their families. Member participation in committees at both the County and local level is important to remain informed on matters affecting older adults.

Senior Council is requested to identify representatives for calendar year 2023 to attend the Orange County Senior Citizens Advisory Council (SCAC) affiliated committees (Attachment 1), and to serve on Senior Council subcommittees (Attachment 2).

ANALYSIS

SCAC advises the Orange County Board of Supervisors and the Office on Aging on matters affecting older adults in Orange County. SCAC holds monthly general meetings, bringing service providers and advocates together to advise on relevant issues such as: senior needs assessments, service planning, and legislative advocacy. SCAC consists of an Executive Board and three standing committees.

Senior Citizens Advisory Council (SCAC) – Consists of 40 volunteer citizens, including local elected officials; representatives of health care and supportive service provider organizations; persons with leadership experience, and members of the general public. SCAC membership is comprised of at least half the members aged 60 and older. The Orange County Board of Supervisors appoints 10 members; the California League of Cities appoints 10 members; and the Executive Board appoints the remaining 20 members.

Housing & Transportation Committee – Addresses the housing needs of older adults in Orange County, including affordable housing and accommodations for individuals with disabilities. This committee also addresses transportation issues affecting older adults who are unable to drive and/or have functional impairments.

Senior Citizens Engagement Committee – Researches and tracks legislation affecting older adults.

Wellbeing Reimagined Committee – Addresses health issues that impact older adults, including access to health insurance and health care, and nutrition needs of older adults, especially the homebound and others in greatest social and economic need.

Senior Council subcommittees advise Senior Council and staff on matters affecting Irvine seniors, including programs and services at Lakeview Senior Center, Rancho Senior Center, and Trabuco Center.

Facilities Subcommittee – Provides input on safety and maintenance needs of senior center facilities. Provides recommendations to Senior Council and staff on proposed facility improvement projects.

Nutrition Subcommittee – Raises awareness of senior nutrition topics and solicits input on nutrition program operations and menus. Provides input on nutrition-related special projects and events.

Strategic Plan for Aging Subcommittee – Remains current on regional and City strategies for the development of programs and services for Irvine seniors. Provides input on yearly action items and serves as ambassadors by sharing input from senior community members. Provides support in the development and implementation of Irvine aging plan initiatives.

ALTERNATIVES CONSIDERED

Senior Council may decide to delay the selection of committee assignments until a future meeting.

FINANCIAL IMPACT

There is no financial impact as a result of selecting Senior Council committee representatives for 2023.
